Thank you for your query. In 2023, consultancy costs charged to the profit and loss account amounted to \in 4.0 million. The main consultancy costs incurred in 2023 related to regulatory consultancy costs of \in 3.2 million, ESG and strategy consultancy costs of \in 0.4 million and other consultancy costs of \in 0.4 million (2022: regulatory consultancy of \in 1.3 million and security consultancy of \in 0.5 million with the remaining other consultancy of \in 0.9 million relating to consultancy on international projects, communications and energy). Specific purpose, value and duration of contracts are subject to commercial confidentiality.

Regarding 2024, this process has not yet been formally finalised. The consultancy costs incurred will be disclosed in the annual report later this year.
