Thank you for your query. In accordance with Guidance Material issued by IAA in December 2024 to all airport operators, daa is required to establish the legitimacy of any request for a private ambulance to access the CPSRA (Critical Part of a Security Restricted Area) at their airports. As detailed in the issued response to Parliamentary Question No. 235, when the airport operator is validating such requests for the attendance of private ambulances, it may consider a health authority, hospital, or insurance company as a reliable source, but it cannot consider a private ambulance operator as a reliable source without independent confirmation of same.

daa has not had any correspondence with the operator in respect of the flight detailed in your query; therefore, we are unable to provide further comment in respect of it. We do appreciate your interest in this issue and would like to reiterate our offer to meet to discuss at a time that is convenient for you. Please let us know if that would be helpful.
