To ask the Minister for Transport the number of IT projects within their Department, or bodies under its aegis, which have been allocated funds in excess of €1 million in the years 2020 to date; the purpose of any projects; the initial estimate to complete for such projects; the total amount expended to date; the total estimated cost to complete; the estimated timeframe by which they expected to be completed; by project; by year; in tabular form; and if he will make a statement on the matter.

Dear Deputy Bennett,

Thank you for your query. Please find below the purpose and estimated timeframe of all relevant IT projects being delivered, or which have been completed since 1 January 2020.

Unfortunately, the requested information around specific project costs is commercially sensitive and cannot be disclosed. It is important to note that daa is a Commercial Semi State Organisation, and not a Public Sector Organisation. This distinction means that legitimate commercial concerns arise for daa that may not apply to some public bodies without a commercial mandate.


